Third, the book provides students with a sense of how constitutional decision making has changed in different historical periods, and how those changes have affected the present Court's understanding of the Constitution. Finally, *American Constitutional Law and History* shows students how to name and use regularly recurring forms of legal argument, such as analogical reasoning, syllogisms, re-framing by varying the level of generality, and a group of arguments characterized as "rhetorical" arguments such as the slippery slope and famous dead person (appeal to authority) arguments.
